Sub – Affiliation Certificate for the school subject to by law Article 8A

Reference – JPR/East/Jai/RTI/Fa –Affiliation/398/ 2012 in order of dated 06/10/12

With reference to the Post View correspondence or supervision of the school, on the basis of the documents presented by the institution and the application dated 13/03/2013, to meet the criteria and amendments in the Pre-order, I grant the recognition (affiliation) for classes 1 to 8 of Maheshwari Public School, Jawahar Nagar, Jaipur .

The above agreement will be subject to the following Terms & Conditions

1. There will be no extension in the agreement period of affiliation and no Compulsion beyond class 8
2. Obedience of the provisions of the Act of Right to Free and Mandatory School Education, 2009 (Central Act 2009, Serial No. 35) and Right to Free and Mandatory Child Education in Rajasthan, 2011.
3. School will provide admission to the children related to vulnerable and suffering groups from class 1 or Pre-primary section till the end.
4. According to Para 3, the school will reimburse Pursuance of the provisions of the Right to Free and Mandatory Child Education Rajasthan, 2011 for the specified children.
5. The Society/School will not charge any per person fees. The parents and the students of these groups will not be subject to any pruning process.
6. The school will not deny/reject the admission of any child in the absence of birth certificate and will follow the provisions of the Clause 15 of the Act of 2009.

The School will ensure that:

- a. The Education of students (from Pre-Primary to class 8) will not be stopped and the child will not be ressticated from the school)
 - b. No Co-orporal punishment for the students.
 - c. It is expected to pass any board exam till the end of his initial education.
 - d. The laid certificate will be provided after the completion of the initial education to each child according to Rule 23 Right of Free Mandatory Child Education, 2011.
 - e. According to provisions of the Act of 2009, the students who are disabled or with special ability will also be included
 - f. The teachers must be recruited with the minimum qualification according to the sub stream 1 of Clause 23 of the act of 2009. But the available/present teachers, who don't have the minimum qualification till the beginning of the act of 2009, have to earn the same within a period of 5 years.
 - g. The teachers have to discharge their specified duties subject to the sub stream 1 of Clause 24 of the Act of 2009.
 - h. The teachers will not involve themselves in any personal teaching activities.
7. School will follow the lesson description on the basis of alleged lesson plan by the proper authorities.
 8. The school will maintain the specified values and standards of clause 19 of the Act of 2009.

The school will provide such reports and information which will be asked from time to time by Director, Basic Education/ District Basic Education officer and will follow the instructions of state govt. /local authority issued to ensure the implementation of terms and conditions of affiliation or to ensure the eradication of the errors.
